Performance Guidelines

- Only approved performers are permitted to busk on Main Street in one of the pre-determined locations.
- Sound amplification is permitted but should be kept at a moderate level so as not to overwhelm adjacent businesses. Battery powered amplification is permitted but not generators.
- All performances are to have family-friendly content and not pose any danger or risk to the public.
- Performances must not block walkways, traffic, driveways or open business entrances.
- Donations during performances are acceptable but any other sales must be approved prior to the performance.
- Performers are to provide a copy of their liability insurance naming the Town of Newmarket as an additional insured on the policy up to the amount of \$2,000,000.
