SUBJECT: Noise Exemption

COMMENTS

The purpose of this information report is to advise Members of Council that the Town has received a noise exemption request from North Rock Group which is the contractor for the Region of York, regarding the work to take place on Bayview Avenue at the Region of Yorks Sewage Pumping Station. The request is for an exemption from the Noise By-law 2004-94 for March 25th and 26th from 7:00 pm to 7:00 am for the connection of the forcemain pipes into the Newmarket Sewage Pumping Station.

North Rock Group is requesting to undertake the work at non-peak hours (7p.m. through 7a.m.) starting March 25th 2015 as once they start the process they cannot stop until the line is installed.

Noise exemptions are normally granted by Council; however, due to the time sensitivity and in the absence of a scheduled Council meeting, staff will be approving the request in accordance with past practices. In accordance with the Procedure Bylaw any Members of Council may request an Information Report to be placed on an upcoming Committee of the Whole agenda for discussion.

North Rock Group will also be preparing a notice to the community to advise them of the work that will be occurring as part of the standard approval process.



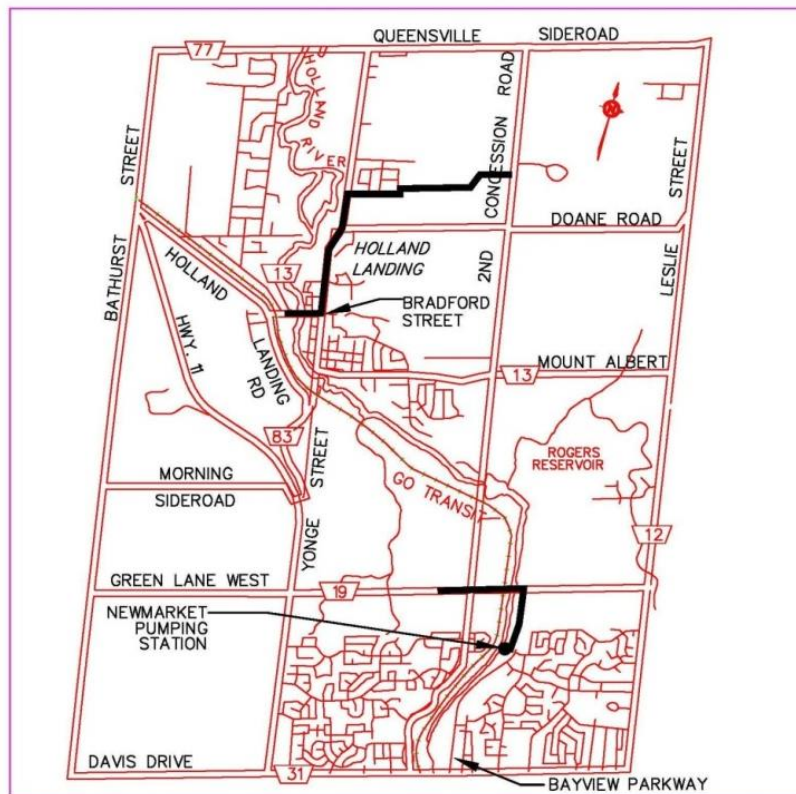
NOTICE OF CONSTRUCTION

**Construction of the Holland Landing and Green Lane Sewer and Water works
Located at Yonge Street and Bradford Street, Green Lane and 2nd Concession
in the Town of East Gwillimbury
and
Leslie Valley Drive and Bayview Parkway in the Town of Newmarket**

The Regional Municipality of York (York Region) will be working in your community to construct forcemains, sanitary sewer and watermains.

These projects were identified in York Region's Long Term Wastewater Master Plan. York Region has awarded a construction contract to North Rock Group for the following works:

- **Holland Landing Forcemains:** Pipes will be installed from the new Holland Landing Sewage Pumping Station on Bradford Street east to Yonge Street, north to Parkside Drive then east to 2nd Concession (see map below)
- **Green Lane Forcemain and Watermain:** Pipes will be installed from 2nd Concession to just east of the Holland River; the forcemain pipes will connect to the Newmarket Sewage Pumping Station (see map below)



North Rock Group Ltd. will be installing a sewer on Bayview Parkway from the working easement to the Newmarket Sewage Pumping Station on Bayview Parkway. The Town of Newmarket has granted an exemption to the Noise Control By-law for the night work on Wednesday March 25 and Thursday March 26 between 7:00pm and 7:00am.

Every attempt will be made to reduce the inconvenience to a minimum.
