
# **COMMENTS**

Finance Report 2015-06 dated February 19, 2015 projected a minimal preliminary 2014 surplus. Since the presentation of the report, some expenses came in slightly higher than originally projected which resulted in a small operating deficit of \$61,696. All transfers have been made that were previously authorized.

The audit field work has been completed. No adjustments were made as a result of the audit that impacted the operating results. Final audited statements will be presented to the Audit Committee in June and then to Council for approval.

## Tax Supported Operating Budget

The Workplace Safety and Insurance Board (WSIB) has an experience rating program that can increase the cost if the claims exceed the WSIB's expectation and issue a surcharge. After year-end, but before the preparation of the financial statements, an unanticipated NEER statement for 2014 in the amount of \$598,000 was received and accrued to WSIB expense. \$476,000 was transferred from the NEER Support Reserve Fund, depleting the fund, and a further \$122,000 was transferred from the Corporate Rate Stabilization Reserve. This had not been factored into the original projection.



At the end of the year, tax cancellations were \$642,000 over budget compared to our projection of \$615,000. \$556,000 was transferred from the Corporate Rate Stabilization Reserve to help offset the higher tax adjustments.

## Newmarket Public Library

The Newmarket Public Library ended the year with a small surplus of \$229 which was transferred to the Library Reserve, bringing the year-end balance to \$488,755.

## Central York Fire Services

The \$10,009 favorable operating variance was transferred to the CYFS Reserve Fund. The balance in the reserve fund at the end of the year is \$851,896. \$1,068,707 in unspent capital was carried over into 2015.

## **Building Department**

Expenditures exceeded revenues by \$171,385, resulting in a transfer of the same amount from the Reserve for Building Permits. As at the end of December 31, 2014, the Reserve for Building Permits had a balance of \$5,316,859 which is used to offset future costs or revenue slowdowns. BMA Management Consultants were hired to do a review and a report on fees is expected in the near future.

## Water & Wastewater

As projected in Finance Report 2015-06, revenue and expenses ended the year under budget. While not at the level budgeted (\$1,560,989), the surplus of \$1,089,450 was transferred to the Rate Stabilization Reserves.

## Capital Fund

Capital expenditures totaled \$20,362,371 compared to a budget of \$51,414,125. \$28,132,006 is to be carried forward to 2015. The total 2015 capital budget, including carryovers, is \$57,465,481.

The 2014 operating deficit of \$61,696 will be covered by a transfer from the Corporate Rate Stabilization Reserve in 2015.
